awareness to focus on the importance of safety procedures while providing personal care in the person-centered process. When discussing an individual's safety skills with his or her circle of support, it is necessary to address his or her skills and independence with bathing and showering activities separately from the person's skills and independence with toileting and dressing. It is imperative that managers and staff members discuss all assistance that may be required for bathing and showering such as adjusting for appropriate water temperature, assistance with washing and rinsing the person's body, assistance with entering and exiting the bathtub or shower, etc. All staff should be aware and mindful of the person's needs as outlined in his or her plan of service. It is recommended that water temperature is tested frequently. There are various procedures for lowering water temperature in the home. The electric or local gas companies may offer service (i.e., adjusting thermostat) at no cost.

It is the responsibility of all TSCS employees to follow all work related policies and procedures to ensure a safe work environment is maintained. Any kind of behavior issues should be documented and reported to the circle of support, treatment team and appropriate parties. Managers should review with their staff the emergency procedures. TSCS and its funding sources provide workplace violence and safety trainings to employees. Such trainings (that address warning signs of violent behavior, explain who is at risk and how employees can protect themselves, what personal conduct they can take to minimize violence, and what to do if an incident occurs, employee work areas, property security, infection control hazards, vehicle safety standards, falls in the workplace, storing of materials, fire safety and hazard communication standards, etc.) have been posted on TSCS website. If any staff member comes across any hazards they should call the office

immediately. If something needs to be repaired staff must follow the *facility work order* procedures. If there is an incident involving an employee, the office must be informed immediately and the completed Claim/Incident Report form must be submitted to the office within 24 hours of occurrence.
